

**TSREDCO invites applications from interested stakeholders for  
TELANGANA STATE ENERGY CONSERVATION AWARDS 2023 (TSECA – 2023)**

Government of India has enacted Energy Conservation Act 2001 and established Bureau of Energy Efficiency (BEE) at National level for implementing the various provision under the said act. Government of Telangana has appointed Telangana State Renewable Energy Development Corporation (TSREDCO) as the State Designated Agency (SDA) under the provisions of EC Act and implementing various energy conservation programmes in the state. Government of Telangana noticed the importance of recognizing the efforts taken by the stakeholders towards reducing the energy consumption in their respective sector and awarding them the prestigious Telangana State Energy Conservation Awards (TSECA) every year during the Energy Conservation week celebrations. As a State Designated Agency of BEE, TSREDCO is implementing this programme. This year the Telangana State Energy Conservation Awards – 2023 (TSECA-2023) is announced and awards will be presented on **20<sup>th</sup> December 2023.**

TSREDCO is inviting applications from various stakeholders of following 11 different categories for TSECA-2023:

- **Category 1: Large scale Industry** - (Large scale industries –All consumers in the State with a total (electricity + fuel) annual energy consumption more than 1000 TOE (Tonnes of Oil Equivalent) – Industrial sectors such as Thermal Power Plants, Pulp & Paper, Cements, Iron & Steel, Chlor Alkali, Aluminum, Fertilizer & Textiles etc. may apply under this category.
- **Category 2: Medium scale Industry** - (Medium scale industries – All consumers in the State with a total (electricity + fuel) annual energy consumption between 200 - 1000 TOE)
- **Category 3: Small scale Industry** - (Small scale industries – All consumers in the State with a total (electricity + fuel) annual energy consumption up to 200 TOE)
- **Category 4: Commercial Buildings** - (Commercial Buildings - new & retrofits- including hotels, hospitals, IT/ ITES Office buildings, Malls, Convention centres etc. who have implemented energy conservation/ efficiency programs)
- **Category 5: Government Buildings** - (Government office Buildings- new & retrofits who have implemented energy conservation/ efficiency programs implemented)
- **Category 6: Educational Institution Buildings** - (Educational institution buildings of Government and Private – where energy conservation/ efficiency programs implemented)
- **Category 7: Educational: Energy Clubs in Schools** - (Energy Clubs in the schools established as per the BEE & TSREDCO guidelines may apply under this category.)
- **Category 8: Railway Station Buildings** - (Railway Station Buildings- where energy conservation/ efficiency programs implemented)
- **Category 9: Transport** (TSRTC individual bus depots may apply under this category)
- **Category 10: Urban Local Bodies** - (Individual Urban Local Bodies such as / Municipalities/ Municipal Corporations/Municipal Councils/ Water and sewerage Boards may apply under this category)
- **Category 11: Gram Panchayats** – (Individual Gram Panchayats may apply under this category)

Any efforts towards energy conservation/ energy efficiency by any stakeholder of the above category in the state of Telangana may apply for this year awards.
